Privacy Policy and Notice at Collection

I.Introduction

This Privacy Policy ("**Policy**") describes how Callie Pappas Global Consulting, LLC ("**CPGC**" or "**we**" or "**us**") handles the Personal Information it collects online. Unless otherwise noted, the information in this Policy that describes how and why we collected, used, and disclosed information within the past 12 months also describes the information we will collect and how we will use it. For purposes of this Policy, personal information ("**PI**") means information that identifies, relates to, describes, can reasonably be associated with, or could reasonably be linked, directly or indirectly, with you or your household.

This Policy applies to interactions you may have with CPGC in your individual capacity or in your capacity as an employee, owner, director, officer, or independent contractor of another company, partnership, sole proprietorship, non-profit, or government agency (collectively, "Entity") that does business with us.

We may change the terms of the Policy from time to time. When we make changes, we will post the amended policy on this website ("**Site**"). If the changes are material, we will post a notice on the Site alerting you to the change. Any changes to the Policy will become effective immediately upon our posting of the Policy, so please review the current Policy before providing us with PI.

II.What Personal Information CPCG Collects and Why We Collect It

We may also collect, use, or disclose the personal information described above for other purposes authorized by applicable laws, including:

- internal data analysis and product development;
- compliance with law enforcement requests or legal process;
- to detect, investigate, prevent, or otherwise address fraud or other security and integrity issues, or to maintain the security and integrity of our products and services (including investigating and responding to ethics complaints);
- to exercise or defend against legal claims, including investigating those claims;
- compliance with applicable laws and regulations; or
- as part of a corporate transaction or proceeding such as a merger, financing, acquisition, bankruptcy, dissolution, or at transfer, divestiture, or sale of all or a portion of our business or assets.

III.Sources of Personal Information

CPGC collects PI about you when you actively provide it to us, such as by completing an online form or sending us an email. We also may collect PI about you from other sources, such as our business partners and affiliates; the Internet or publicly available sources, including social media websites; the press or other print media; from parties to corporate transactions; service providers and suppliers; and other organizations or individuals as permitted under applicable law.

IV.Information We Collect Automatically Online

When you visit our Site, we will collect the following information automatically:

- Technical information, including the internet protocol (IP) address used to connect your computer to the internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system, and platform; and
- Information about your visit, including the full Uniform Resource Locators (URL), clickstream to, through and from the Site (including date and time), products you viewed or searched for, page response times, download errors, length of visits to certain pages,

page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page.

We may obtain this information via server logs, cookies (small data files your web browser stores on your hard drive), web beacons (small electronic images used to count web page views) or other commonly used mechanisms.

Our Site uses cookies to distinguish you as a Site user from other users of our Site. This helps us to provide you with a good experience when you browse our Site and allows us to improve the Site. Every time you return to a Site you previously visited, the browser retrieves the cookie and sends it to the Site's server. We also use cookies that remember the pages you have visited and the links you have followed, which we use and may share with third parties to help make our Site more relevant to your interests. And more broadly, we use cookies to see how many visitors are on our Site and how visitors move around the Site. These cookies help us improve the way the Site work, for example, by ensuring that users are finding what they are looking for easily.

You can block cookies by activating the setting on your browser that allows you to refuse the setting of all or some cookies. By using the Site, you are deemed to unambiguously agree to its use of any cookies that you do not disable.

We also use tools such as Google Analytics (which in turn uses cookies) to learn more about Site visitor preferences and activities when using the Site. Google Analytics uses cookies to collect information about Site visitors to provide analytics services based on a user's visits to sites across the Internet and across other mobile applications. Our Site do not respond to a user's Do-Not-Track request.

V.Who We Disclose Personal Information To

We have disclosed, or may disclose, each category of PI described above to these categories of recipients:

- to our service providers, whom we engage to assist us with technology support, operational support, and other forms of assistance, and whom we bind by contract to protect the confidentiality and security of the PI we share with them;
- in the event of a proposed or actual reorganization, merger, sale, joint venture, assignment, transfer or other disposition of all or any portion of our company or its assets, to the proposed or actual acquiring party or assignee;
- to law enforcement agencies, courts, and regulatory agencies when the disclosure is required or permitted by law, including to comply with valid legal process; or
- to other parties as we believe to be appropriate (i) when required by applicable law, including laws outside your country of residence; (ii) to comply with legal process (iii) to respond to requests from public and government authorities; (iv) to enforce the terms and conditions for use of the Site, including this Policy; (v) to protect and defend our rights and property; (vi) to protect the interests of CPGC or others; and (vii) to permit us to pursue available remedies or limit the damages that we may sustain.

We do not sell PI and we do not share PI with non-affiliated entities for them to use for their own marketing purposes.

VI. Additional Disclosures and Rights for Residents of California

This section provides additional disclosures and describes additional rights applicable to residents of California under the California Consumer Privacy Act ("CCPA"), as amended. Capitalized terms in this section have the same meaning as the matching terms defined in the CCPA.

You have the right not to be discriminated against for exercising your CCPA rights.

A. Right to Opt Out of Sales and Sharing of Personal Information

Within the preceding 12 months, we Shared identifiers, commercial information, geolocation information, internet or other electronic network activity information, or inferences for marketing and advertising purposes with advertising and digital analytics companies, social media platforms, and data analytics firms.

Right to Delete. You have the right to request that we delete Personal Information under certain

circumstances, subject to several exceptions.

Right to Correct. You have the right to request that we correct Personal Information that we maintain about you if you believe it is inaccurate. We may request documentation from you in connection with your request. Upon receipt of a verifiable request to correct inaccurate Personal

Information, we will use commercially reasonable efforts to correct the Personal Information.

VII. Additional Disclosures and Rights for Residents of Virginia

This section applies to Virginia consumers, as defined by the Virginia Consumer Data Protection Act ("VCDPA"), that access or use our products or services. This section describes our collection, use, and disclosure of "Personal Data" (as defined in the VCDPA). Right to Correct. You have the right to request that we correct inaccuracies in your personal data.

Right to Delete. You have the right to request that we delete personal data we have collected from or obtained about you.

Right to Opt Out of Targeted Advertising. You have the right to request that we stop disclosures of your personal data for targeted advertising. You may opt out of Targeted Advertising by adjusting your Cookie Settings through the "Cookie Settings" link in the footer of our website.

Right to Opt Out of Sales. You have the right to opt out of our Sales of your Personal Data. Please note that we do not Sell your Personal Data.

Right to Opt Out of Profiling. You have the right to opt out of profiling in furtherance of decisions that produce legal or similarly significant effects. We do not profile in a manner that would result in legal or similarly significant effects and as such do not offer this right.

Right to Appeal. If you are unsatisfied with our actions related to the exercise of one of your privacy rights above, you may appeal our decision.

- whether your PI is reasonably necessary to carry out a disclosed purpose that is reasonably compatible with the context in which the personal information was collected;
- whether the PI is reasonably required to protect or defend our rights or property (which will generally relate to applicable laws that limit actions in a particular case); or
- whether we are otherwise required or permitted to keep your PI by applicable laws or regulations.

Where PI is used for more than one purpose, we may retain it until the purpose with the latest period expires. For more information about our retention policies, please contact us using the contact details below.

We endeavor to use reasonable organizational, technical, and administrative measures to protect the PI we maintain within our organization.

IX.Site Use Limitations and International Visitors

Our Site is not directed to users under the age of 18 and we do not knowingly collect PI online from any person we know to be under the age of 18.

Our Site is designed for users from, and are controlled and operated by us from, the United States, which may have different data protection rules than those of your country.
